Proposed new carpark to cater for larger vehicles such as motorhomes and caravans, whilst also including provision for general car parking. Refer sheet 2 for more detail. 2 Proposed new fenced dog off-leash park area with seating, litter bins, shade tree plantings and irrigated turf. Timed, shrouded solar lighting to ensure sensitivity to adjacent residents, 2 x shaded picnic tables and drinking fountains are to be located outside the perimeter of the dog park. Future provision to be made for dog agility equipment. Refer sheet 2 for more detail. **3** Existing footpath network. Proposed new "Short-Term Playground" for travellers to have an active rest stop with family. Also available for local use, the space and surrounds provide a shady, comfortable area with bench seating and a picnic shelter amongst a bosque of large planted trees looking out to the play area. Refer sheet 2 for more detail. Solution States Stat new carpark to existing circuit path and new playground. 6 Proposed new car park for the short term playground and general park use. Refer sheet 2 for more detail. Proposed new main playground adjacent to existing skate park zone designed by others. This nature-inspired playground shall provide a free play area, sensory pathways, various play/ breakout stations and a playground suited to 4-8 years. Seating and breakout zones for older children shall be created using natural elements such as large rocks and strategic plantings, with formalised seating and tables close by for


