### The Position

Council is seeking the services of a person to fill the position of Sealed Network Plant Operator/Labourer. The successful applicant will be responsible for undertaking a range of plant operation and labouring tasks as part of a multi-disciplined team that is responsible for the maintenance or construction of roads, traffic furniture or any other associated structure. The applicant must have the ability to work in a manner that will provide a safe work environment in accordance with Council's Workplace Health and Safety policies and procedures.

### Qualifications and Experience

The successful applicant will have demonstrated experience in general maintenance and labouring duties and hold a current 'MR' Class Licence and General Construction White Card. The successful applicant is expected to have, or be working towards a Certificate III in Civil Construction or equivalent experience, working at heights certification, traffic control certificates along with appropriate certificates of competency to operate a Roller and Skidsteer.
