Application to Register a Cat and/or Dog

To register a dog with Longreach Regional Council the owner must: Under sections 44-46 of the *Animal Management (Cats & Dogs) Act 2008* an owner must:

- Complete this registration form in full,.
- Ensure the animals Microchip number is supplied, this helps Council in returning your pet if it escapes.
- Pay the associated registration fee;
- If the dog is desexed – supply a signed veterinary certificate or other evidence, stating that is has been desexed;
- Register a dog that is older then 12 weeks, within 14 days after starting to keep the dog in the area;
- Ensure that the dog bears the registration tag;

Obligation of owners to Microchip

Under section 14 of the Animal Management (Cats & Dogs) Act 2008 a person who is or becomes the owner of a cat or dog that is not implanted with a PPID (microchip) must ensure that the cat or dog is implanted with a microchip before it is 12 weeks old unless the person has a reasonable excuse. Note - A cat or dog that is more than 12 weeks old when a person who is or becomes the owner need not be implanted with microchip unless it is supplied.

Prohibition on Keeping Dogs within the Longreach Regional (local government area)

It is prohibited to keep the following without a permit:

1. More than 3 dogs over the age of 3 months on an allotment in the designated town area;
2. More than 1 dog over the age of 3 months on a multi-residential premises;
3. any of the following breeds anywhere in the local government area:
 - American Pit Bull Terrier or Pit Bull Terrier;
 - Dogo Argentino;
 - Fila Brasileiro;
 - Japanese Tosa;
 - Perro de Presa Canario or Presa Canario
