## **Judging Process**

Nominations will be reviewed by the appointed judging panel. The judges decision is final and no correspondence will be entered into.

#### Eligibility

- 1. Nominees must reside within the local government boundary of Longreach Regional Council. Community events must be held within the local government boundary of Longreach Regional Council.
- 2. Nominees cannot have won an award in the same category in the last two consecutive years.
- 3. Nominees must be within the accepted age range of the award.
- 4. Current elected members are not eligible for nomination.

Must be aged 18 years or over as at 26 January 2024.

- How is the nominee an inspirational role model for the community?
- What is the scope of impact the individual's contribution has on the region?
- In which field/area has the nominee made the most significant contribution?

## 3 JUNIOR ACHIEVEMENT OF THE YEAR (Sporting, cultural, individual or team)

This award will recognise the individual who has made a significant contribution to the growth or development of the community, and/or given outstanding service to the local community. An individual who has made a noteworthy contribution to the cultural life of the community or who has attained outstanding achievement in cultural activity/ies during the past year, or over a number of years. Must be <u>under</u> 18 years as at 26 January 2024.

#### Selection Criteria

- · How is the nominee an inspirational role model for the community?
- What is the scope of impact the individual's contribution has on the region?
- In which field/area has the nominee made the most significant contribution?

## 4 COMMUNITY EVENT OR COMMUNITIY GROUP OF THE YEAR

This award will recognise community groups, not-for-profit organisations or associations that have made a noteworthy contribution to sport, cultural life of the community or who has attained outstanding achievement in cultural activity/ies. An individual or group who has staged the most outstanding community even during the past years, or over a number of years.

#### **Selection Criteria**

- What social, cultural and/or economic benefits has the event brought to individuals, community organisations, businesses or the community in general?
- How has the group demonstrated leadership in and for the community?
- What is the groups involvement in the community?
- · What impact has the group's contribution had on the region?
