PURPOSE

The purpose of this policy is to assist Council to make a fair and equitable decision in the provision of vehicular access to properties. The policy only applies where there is a barrier (vertical face) kerb and channel and where there is no sealed rear lane access.

SCOPE

Longreach Regional Council has barrier kerb and channel in a number of roads and requires modification to allow vehicular access to a property, generally to the front of the residence from the street. Most properties have rear lane access, however most are unsealed.

POLICY STATEMENT

That Council shall construct the first vehicle access (cross-over) to a sealed road, if the following criteria, in order of priority, are satisfied:

- a. Barrier kerb and channel currently exists (this is not relevant to mountable type kerbing, or where there is no kerb and channel);
- b. The property has no existing laneway or street cross-over;
- c. the property has no existing sealed laneway or street cross-over; and
- d. Council budget constraints, workload and discretion.

In instances other than the above, the administering Local Laws shall apply.

The property owner will be responsible for any additional vehicle access if required, subject to Council approval. The cost of repair or replacement of a vehicle access (cross-over) will be the responsibility of the property owner.

DELEGATIONS

Council delegates the Director of Infrastructure Services the responsibility to amend the policy, procedures and design specifications appropriately, as required.
